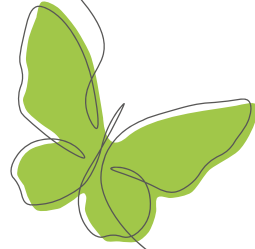

For hundreds of families across Wales, Tŷ Hafan is simply a lifeline when there is nowhere else to turn to.

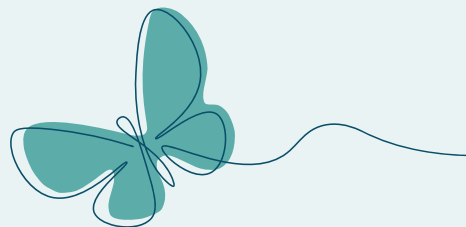

About Tŷ Hafan

We are the leading Welsh children's charity, providing care, comfort and support to children with life-shortening conditions and their families across Wales.

Today, **gifts left to Tŷ Hafan in people's wills fund 25% of the care that we provide**; that's a quarter of the money we need to support the families who we are privileged to work with every year. We bring laughter and light to many children, ensuring their life, though short, is as full as possible.

We provide a safe haven for their families, to help them to make precious memories to cherish, as well as cope with the day-to-day demands of caring for a child whose health is severely compromised.

Since 1999, gifts in wills have played an instrumental role in funding the development and expansion of our care programme – both at our hospice in Sully in the Vale of Glamorgan and within communities across Wales.

A gift, no matter how big or small, will have a significant impact on our care services, enabling us to be a lifeline for all those children and families in Wales who so desperately need our care and support for many years to come.

Ollie's story

Sophie and Sean were just 22 when their little son Ollie was diagnosed with the ultra-rare MOSAIC Syndrome.

“Ollie is our second child, a baby brother for Summer. He had to be resuscitated after he was born but after that he was sent to a normal ward,” says Sophie. “He had a sacral dimple on the bottom of his spine and when I asked about this, one of the junior doctors said that Ollie had ‘unusual features’ - wide-set eyes and low set ears but the other doctors dismissed her.

All in all, it was four months between his birth and Ollie being admitted to hospital, where he fed for the first time through a nasal gastric tube. Bless him, it was the first time I'd ever seen him content after that feed. He was then admitted to hospital and they did loads of checks on him. The doctors told us that they had seen all these features, but individually, not together.”

Eventually Ollie was diagnosed with MOSAIC Syndrome.

“My husband Sean and I were just 22. We were sent away with a Google printout about the condition after a 10-minute appointment. And there were no recommendations as to where to go for further support.”

It wasn't until Ollie was 18 months that the family had their first experience of Tŷ Hafan.

Ollie was just 18 months old when he first stayed at Tŷ Hafan in September 2019, after he came out of hospital and has been a few times since. I had been afraid of what it was going to be like, but it was lovely, not clinical at all. Everyone's happy and running around trying to give the kids the best time.

But it's not just the respite stays. If I'm having a really a bad day, I know that someone at Tŷ Hafan will have the time to just sit and listen to me. Me and Sean don't talk about what we're going through; we just try to get on with things. So for us, Tŷ Hafan is absolutely brilliant, a total lifeline.

Summer has also had counselling as she was so upset when my sister passed away. It was her first experience of death. After that she was waking up in middle of night, crying, running into Ollie's room to make sure that he was still breathing. Now, thanks to the counselling she has had from Tŷ Hafan, Summer feels able to talk about what's going on more. Its Ok to cry, it's Ok to be upset. Already, Ollie has been emergency transferred to Tŷ Hafan two or three times for end-of-life care. Counselling has definitely helped her to deal with this.

If we did not have support from Tŷ Hafan, we would have no respite at all.

Tŷ Hafan has been there for us all the way. The nurses there have known

Ollie all his life and they are amazing with him. The hydrotherapy pool is amazing, and so is socialising with other children and families. Through the Super Sibs group, Summer gets to speak to children in same position as her and she absolutely loves that.

One time, I was almost overwhelmed and I went to Tŷ Hafan. One of the nurses, Adrian had just finished working but it didn't matter. He just sat with me and listened. That gave me enough to get up and go on."

Your gift could make all the difference

From round the clock medical care to bereavement support, your gift no matter the size will have a significant impact on our care services.

1% of the average estate value

could pay for over two years supply of oxygen used at the hospice.

2% of the average estate value

could give a family five days of short break care at our hospice, helping the whole family get some much need respite plus all the medical supplies used at the hospice for a month.

2.5% of the average estate value

could pay for a specialist adaptable cot which keeps children safe, secure and comfortable, accommodating ventilation machines and feeding tubes.

5% of the average estate value

could pay for one and a half days of expert medical care and support at our hospice. This includes all medical supplies, equipment, expert staff and therapy costs in the hospice and community.

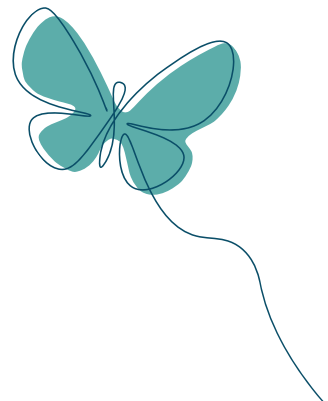
10% of the average estate value*

could pay for a Tŷ Hafan nurse to provide specialist paediatric palliative care to a family for an entire year.

Gifts left in people's wills have allowed us to upgrade our medical equipment, renovate areas of our hospice and broaden the vital services offered to our families.

One significant gift helped create the first of its kind in Wales - our Transformers project; a service which supports children and their families during the transition into adult care services, offering crucial support and guidance.

Types of gifts that can be left in wills

After providing for those close to you, there are a variety of ways you can choose to leave a gift in a will:

A share of your estate:

This is also known as a 'residuary gift' and is a percentage of your estate.



A cash gift:

This is also known as a 'pecuniary gift' and is a fixed amount of money.



A specific gift:

This is a named item such as a house, jewellery or stocks and shares.



An inflation protected cash gift:

This is also known as an index linked pecuniary gift and is a fixed amount of money where the value remains the same as it is protected by any inflation increases.

What is inheritance tax?

Inheritance tax is the amount of money that will need to be paid to the government from your estate if it is over a certain value. By leaving a gift in your will to charity, you may be able to reduce or eliminate your inheritance tax liability. A gift to charity is tax-free and is taken out of your estate before your tax is calculated. If you leave 10% of your net estate to charity, you can reduce your inheritance tax rate from 40% down to 36%.

If this is something you wish to consider, we recommend that you talk to a solicitor or HMRC for further advice and information.

Our free will writing offers

We have partnered with the **National Free Wills Network** to offer our supporters the opportunity to meet with a local solicitor and write a simple will (or pair of mirror wills) for free.

How to write a will

Writing a will gives you the peace of mind that your loved ones will be looked after and is the only way for you to choose what happens to your estate and personal possessions once you pass away.

We recommend you use a solicitor or legal professional to write your will. Tŷ Hafan have partnered with the National Free Wills Network to help you write your will for free (you can find out more about our free will writing offer on page 11).

Here are four simple points to help you plan for writing your will:

- **Make a list of your assets and their value.**

This is valuable information to take with you to your solicitor. Your assets can include elements such as property, savings and other key items of value.

- **Make a list of outstanding finances.**

Please consider any outstanding mortgages, loans or bills. Taking this into consideration will give you a clearer understanding on how much your estate is worth.

- **Decide a list of beneficiaries.**

Your beneficiaries could include your family and close friends, as well as any charities you would like to support. Making a list of your beneficiaries will help you decide how you would like to divide your estate between them.

- **Arrange an appointment with your solicitor.**

This could be face to face, online or over the telephone. An executor will need to be chosen to implement the terms of your will and to ensure your wishes are carried out correctly. Most people choose a solicitor or family member as their executor.

Remember to keep your will safe and up to date. Most people choose to leave their will in the care of their solicitor or legal professional, as well as keeping their own copy in a safe place known to their executor.

Updating an existing will

If you would like to amend your will you can either revoke your current will and make a new one or you can add an amendment/s to your current will. This amendment is known as a codicil and must be written and signed in the presence of two independent witnesses.

FAQs

1. Do I have enough to leave a gift?

Absolutely. We appreciate all gifts, however large or small, and every pound we receive will make a difference to the lives of children with life-shortening conditions in Wales.

2. Can I write my own will?

As a will is a legal document, we highly recommend that you write or amend your will through a qualified solicitor or will writer. Find more information about our free will writing offers on page 11. This will ensure that your wishes will be carried out successfully.

3. What happens if my circumstances change?

If your circumstances change you will need to draft a new will to amend or update your current will, this is called a codicil. Your new will will supersede any previous decisions.

4. Should I let Tŷ Hafan know if I leave a gift in my will?

This choice is yours as to whether you choose to tell us. However, if you do let us know, we can take the opportunity to thank you personally and it will help us to plan for the future.

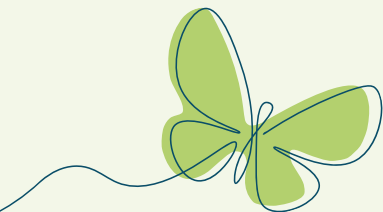
5. Why not help now rather than later?

We truly appreciate all the support that we receive. We know that there will be more families to help in the future and gifts left in people's wills will help protect the longevity of our care for many years to come.

6. Does Tŷ Hafan pay for the free will services and why?

As a charity, we carefully consider how we spend our money. We have fixed fees for the services agreed with the National Free Wills Network which cover the cost of simple wills.

Please note, you may be liable to pay any extra costs needed for complex wills; these are to be discussed with your will writing service provider or solicitor. Tŷ Hafan pays for supporters to write or amend a simple will or pair of simple wills, as removing the need for supporters to pay for their will helps to raise vital income for the charity.
